<b>Housatonic River Mooring:</b>

<sup>1</sup> Non-Motorized Vessel Storage includes annual boat ramp permit and shall be subject to vessel size and storage availability as determined by the Harbor Master or Harbor Management Operations Director. Only one dinghy, kayak, or paddle board may be stored in the assigned space. All vessels must display a current year decal.

<sup>2</sup> Hourly stays over 3 hours but less than 6 hours will be billed \$2.00 / ft. Hourly rate does not include electricity. Stays over 6 hours will be billed at the Marina Overnight rate.

<sup>3</sup> Fees are per foot, subject to twenty-four (24) foot minimum charge, plus electricity. Stays in excess of 6 hours shall be considered overnight. The Harbor Management Commission shall have the discretion to impose minimum stays for holidays and special events.

<sup>4</sup> Fees are annual, per linear foot, including all projections, subject to twenty-four (24) foot minimum charge, plus applicable state tax per authorized space.
