NOTICE TO CITY OF MILFORD, CONNECTICUT TAXPAYERS

The first installment of the October 1, 2019 Grand List Tax Bills is due on July 1, 2020. If the installment is not paid on or before August 3, 2020*, it is subject to interest at the statutory rate of 1.5 percent per month, calculated from July 1, 2020 or a \$2.00 minimum, whichever is more. All bills \$200.00 or less are due in full July 1, 2020. This applies to REAL ESTATE TAXES/SEWER SERVICE FEES, MOTOR VEHICLE TAXES, AND PERSONAL PROPERTY TAXES.

Anyone who purchased property since October 1, 2019 or who has recently paid off a mortgage and does not have a tax bill, should call the Tax Office at (203) 783-3217 so that a bill can be sent. By statute, failure to have received a bill does not exempt the taxpayer from payment of all taxes and all interest charges and all collection costs/fees. Interest is charged on all late payments by statute, no exceptions.

Residents are encouraged to take advantage of the contactless options available for making payments. This includes making payments: Online, By Mail or by Drop Box. Do not deposit cash in any drop box.

Please mail the correct bill coupon with payment to Milford Tax Collector, P.O. Box 3025, Milford, CT 06460. To be on time, payment must be received or USPS postmarked by August 3, 2020*.

If you have extenuating circumstances and need to pay In Person, bring ALL COPIES of the bill(s) to Tax Collector, 70 West River St., Milford, CT. **Please review updates for the City's COVID-19 Protocol. In Person time and availability is subject to change.** Tentative Schedule/Start 7/1/2020: 8:30am-10:00am Senior/Age 65+ and General Public 10:00am-2:00pm Monday – Friday.

COLLECTION HOURS: Monday – Friday, 8:30 AM TO 4:30 PM. Closed July 3, 2020 for Holiday. **Subject to change for COVID-19 Health & Safety Protocol. See tentative schedule/start above.**

If a receipt is required, mail the entire three-part bill including a self-addressed stamped envelope to: TAX COLLECTOR, P.O. BOX 3025, MILFORD, CT. 06460.

Debit/Credit card payments may now be made in person or online. The service provider, Point and Pay, charges a fee to the taxpayer for this service. www.ci.milford.ct.us/tax-collector and select "view and pay tax bills." Please read disclosure for fee schedule.

*If applied & approved for COVID-19 Tax Relief Deferral Program the installment must be paid by October 1, 2020.
