NOTICE TO CITY OF MILFORD, CT TAXPAYERS

To the taxpayer(s) who APPLIED and were APPROVED for the COVID-19 Municipal Tax Relief Deferral Program under Executive Order 9R: if the January 1, 2021 tax installment is not paid on or before April 1, 2021 it is subject to interest at the statutory rate of 1.5 percent per month, calculated from January 1, 2021 or a \$2.00 minimum, whichever is more.

Notice is hereby given to the taxpayers of the City of Milford, CT that the second installment of taxes on Real Estate/Sewer Use charges, Personal Property, Motor Vehicle as well as the Supplemental Motor Vehicle Taxes on the October 1, 2019 Grand List are due and payable on January 1, 2021.

If the taxes are not paid of USPS postmarked on or before February 1, 2021*, such tax bill be considered delinquent and subject to interest at a rate of 1.5 percent per month from the January 1, 2021 due date (\$2.00 minimum).

Residents are encouraged to take advantage of the contactless options available for making payments.

Drop Box: Do NOT deposit cash payments. Exterior drop box available 24/7 located outside the Parsons Building on the sidewalk near the entrance to the Tax Office.

By Phone: (only through secure service provider Point and Pay) 877-495-2729. Service fees apply.

In Person: If you have extenuating circumstances and need to pay in person, the office is open Monday-Friday 8:30am-2:00pm, except holidays. Recommendation 8:30am-10:00am for seniors/age 65+ and 10:00am-2:00pm for the public. Please enter Door # 2 Handicap Entrance and Exit Door # 3. Mask and Social Distancing enforced. Payment in person may be made by cash, check or credit/debit card at the Milford Tax Collector's Office, 70 W River St, Milford CT 06460. Service fees apply for credit/debit card transaction.

*If applied and approved for the COVID-19 Municipal Tax Relief Deferral Program, the installment must be paid or USPS postmarked by April 1, 2021.
