- 1. Completed application form.
- 2. Copy of your <u>current</u> vehicle registration(s). Please do not send original(s).
  - a. Vehicle must be registered in Milford and/or registered to a Milford Taxpayer.
  - b. If your vehicle is not registered in Milford, you may be eligible as a taxpayer or tenant but additional information is needed\*. Please contact the office at 203-783-3217 or visit www.ci.milford.ct.us/tax-collector.
- 3. All taxes must be current.
- 4. Residents wishing to receive their sticker **<u>by mail</u>** must include all the required information listed PLUS a self-addressed, stamped envelope.

\*If you are a tenant and your vehicle is not registered in Milford, you must provide the current vehicle registration and a lease or sworn affidavit from your landlord stating you lease within the City of Milford for the current time period. The name on the vehicle registration must match the name on the lease or affidavit. Affidavit available at www.ci.milford.ct.us/tax-collector \*If your vehicle is registered outside of Milford, and you own property in Milford, you must provide the current vehicle registration must match the name on the lease or affidavit. Affidavit available at www.ci.milford.ct.us/tax-collector \*If your vehicle is registered outside of Milford, and you own property in Milford, you must provide the current vehicle registration and reference the property you own in Milford. The name on the vehicle registration must match the name on the Milford property.

\*If you are a resident taxpayer and your vehicle is registered to a company outside of Milford, you must provide the current vehicle registration and a letter from the company authorizing your usage of the vehicle. Please have the letter state the identifying vehicle information, along with your name and address.
