Resident Parking Sticker Common Eligibility Scenarios

Below is a review of common scenarios of eligibility for a Resident Parking Sticker. Please look at the requirements for <u>In Person</u> versus <u>By Mail</u> versus <u>Online</u> sticker requests. In all scenarios the registration must be current and unexpired. For further review, please follow up directly with a representative from the Office of the Tax Collector. Phone: 203-783-3217

• Vehicle is registered in Milford (to a Person or Business)

- <u>In Person</u>: present copy of vehicle registration
- <u>By Mail</u>: copy of registration, application & self-addressed, stamped envelope
- <u>Online</u>: copy of registration

• Vehicle is NOT registered in Milford, but own property in Milford

- Name on vehicle registration must match name of ownership on Milford property tax bill
- <u>In Person</u>: present copy of vehicle registration and notify of the property address you own (or show property tax bill)
- <u>By Mail</u>: copy of registration, application (notate property you own) & self-addressed, stamped envelope
- <u>Online</u>: copy of registration

• Vehicle is NOT registered in Milford, but rent/lease property in Milford

- Name on vehicle registration must match name of tenant on lease document
- Length of Lease must be for a year-round tenant 12 months or more OR summer tenant renting for one month or more
- In Person: present copy of vehicle registration and lease document
- <u>By Mail</u>: copy of registration, application, copy of lease document (usually just first and/or last page which shows Name, Address & Duration of lease) & self-addressed, stamped envelope
- <u>Online</u>: copy of registration, copy of lease document (usually just first and/or last page which shows Name, Address & Duration of lease)

• Vehicle registered to a BUSINESS (outside of Milford), but driver resides in Milford

- <u>In Person</u>: copy of vehicle registration, signed letter from business identifying Milford resident as sole operator of vehicle & verification of residency*
- <u>By Mail</u>: copy of registration, application, signed letter from business identifying Milford resident as sole operator of vehicle, verification of residency* & self-addressed, stamped envelope
- <u>Online</u>: copy of registration, signed letter from business identifying Milford resident as sole operator of vehicle, verification of residency* (upload document in lease agreement step)
- *If driver resides in Milford, must verify residency against property ownership or rent/lease agreement

• Vehicle is NOT registered in Milford, but own/operate a business in Milford

- Any association, corporation, business or individual owning commercial real estate or personal property and paying taxes thereon is entitled to have ONE individual designated as eligible to obtain a parking sticker
- <u>In Person</u>: present copy of vehicle registration and ownership of business real estate or personal property
 - Review against Milford real estate or personal property bill; and
 - Review against State of CT CONCORD listing (or comparable document)
- <u>By Mail</u>: copy of registration, application, copy of proof of ownership of commercial real estate or personal property (or comparable proof of business ownership) & self-addressed, stamped envelope
- <u>Online</u>: copy of registration, copy of proof of ownership of commercial real estate or personal property (or comparable proof of business ownership) (upload document in lease agreement step)
