- Mayor's Initiative The proposed and approved project for the City will take place in the spring, when the ground finally softens and the snow stops.
- Our Budget Money Tree Areas to be planted A Pear tree needs to be replaced at Robert Treat Parkway. Also, on Old Gate Lane in the triangle plot needs a tree replaced. Bryan Mancini will inquire as to whether the plot belongs to the City or the State. If not State-owned, we can replace a tree there.
