### F. STREET TREE MATTERS

• An update on this Heron/Tree issue: The Tree Warden is not allowing the tree to be cut down under any circumstances. This is regarding the Oak Tree on Kirkside Avenue, corner of Brookdale that is containing several nests and Yellow Crowned Night Heron living in this tree.

#### G. ARBORETUM

- A sign at the Arboretum that has been missing since the Hurricane was to have been already replaced; however, it has not as yet. Kate Orecchio will call Mr. Sign to inquire as to the status of this sign being replaced.
- The planting of the Homestead Elm that will replace the old Elm at the Chamber Building will take place this Saturday at 1pm. It will be delivered to the area tomorrow and will be partially planted, with the actual official planting to take place Saturday. The Mayor and other dignitaries will be in attendance and will

- also be open to the public. It will be planted nearby where the old Elm was originally planted, also in the area of the cannon. The Chamber people were not aware that this tree would be replaced.
- There are two other trees that will be planted on the Green on Saturday; a London Plane (Platanus x Acerifolia) in front of the "Waterbury Lock" building which is a memorial tree (10:00am), and a tree for Allan Brandt's wife Barbara Collins near the Rainbow Gardens restaurant at 11:30am.
- Milford Trees, Inc. had a Clean Up Day on Saturday, March 31<sup>st</sup>, where debris, gators, pvcs, etc. were cleaned up and removed around the trees and the area on the Green. The new Cherry at the head of the Green was not touched as the Pimento family is continuing to maintain the tree.
