VETERANS, CEREMONY AND PARADE COMMISSION REGULAR MEETING JULY 11, 2016

- 3. The Milford Garden Club proposed installing a Blue Star Memorial Marker in front of the Fowler Building and anticipate installation on/about Memorial Day 2017.
- 4. Discussion ensued as to location, what veteran organizations would be included, etc.
- 5. G. Smith made a motion to return to regular business. Seconded by C. Smith; all in favor.
- I. Blue Star Memorial Marker Program G. Smith made a motion that the Veterans, Ceremony and Parade Commission forward its approval and recommendation to both the Mayor's office and Board of Aldermen Chairman and leadership in support of the Milford Garden Club project to install a Blue Star Memorial Marker on the grounds of the Fowler Building, as described by the members of the Milford Garden Club. Seconded by N. Mackenzie; all in favor. G. Smith made a motion that the sign display the Veteran Service Organizations in Milford, if there is enough room. In lieu of that, if there is not enough room, Veterans, Ceremony and Parade Commission. Seconded by J. Jansen; all in favor. Exact wording to be further discussed with all VCPC members at a later date.

V. Unfinished Business

- 1. Building Maintenance / Repairs

 - e. DAV has ordered flag.
- 2. August 2016 Meeting
 - a. Motion made by G. Smith to hold the August 2016 VCPC meeting at the Veterans Memorial Auditorium. Seconded by J. Jansen; all in favor.
 - b. Along with the Mayor, we will be inviting the two members of the Board of Aldermen who are official liaisons to the VCPC.
 - c. Review proposals and determine how VCPC would like to proceed on the Auditorium.
- 3. Milford Bank's "Milford Moves 5K Race"
 - a. All required program documentation received by the VSOs.
 - b. Motion made by G. Smith that the funding for all of the groups be distributed equally (American Legion, VFW, VVA), except for DAV, which would receive a larger percentage
 - c. G. Smith rescinded his previous motion; C. Smith seconded; all in favor.
 - d. Motion made by G. Smith to proportion the funds received from Milford Bank's "Milford Moves 5K Race" as follows: 32.5% DAV; 22.5% for each of the remaining organizations (American Legion, VFW, VVA), and to require each of the organizations to submit, by April 30, 2017, an itemized accounting of how those funds were spent. Seconded by J. Jansen; all in favor.

VI. New Business

- 1. W. Kates advised the Committee that Liberty Rock Park is not being properly maintained. G. Smith made a motion for VCPC to further investigate maintenance of the park. Seconded by C. Smith; all in favor.
- 2. 4th of July Parade attendance and participation was discussed. Consensus was that the parade was well attended. G. Smith made a motion that the ceremony involving the deceased members of the veterans groups be moved to the Veterans Day ceremony at the Doughboy monument rather than the Independence Day ceremony at the monument. Seconded by C. Smith. J. Jansen made motion to table until September; seconded by N. Mackenzie.
- 3. Selling bricks for Founders Walk was discussed. Chairman Flowers to research further with James Maroney with the Founders Walk Committee.
- 4. G. Smith requested the VFW have their same spot at the 2016 Oyster Festival. The DAV and VVA would also like their same spots.

- 1. Ed Monroe personally thanked Chairman Flowers for a well-organized July 4th event.
- 2. C. Smith discussed the creation of a VCPC Facebook page, which will detail all VCPC events.
